### **Hartington Town Quarter Parish Council NEIGHBOURHOOD PLAN DECISION STATEMENT**

This Decision Statement is published pursuant to the Paragraph 6 Schedule 4 of the Town and Country Planning Act and Regulation 15 of the Neighbourhood Planning (General) Regulations 2012

#### **1. Summary**

1.1 At the meeting of the Peak District National Park Planning Committee on 17 January 2025, the Peak District National Park Authority, resolved that they are satisfied that the matters have been met or complied with at Regulation 15 of the Neighbourhood Planning (General) Regulations 2012.

1.2 The Hartington Town Quarter Parish Council neighbourhood should now be taken to Regulation 16 consultation and examination, in accordance with Neighbourhood Planning (General) Regulations 2012.

#### **2. Background**

2.1 The Peak District National Park Authority designated the area comprising the Hartington Town Quarter Parish as a Neighbourhood Area for the purpose of preparing a Neighbourhood Plan on 8th February 2013.

2.2 In accordance with Neighbourhood Planning Regulations Part 5 (14), the plan was publicised and representations were invited firstly in October 2018 and secondly December 2021.

2.3 Following submission of the draft plan and supporting documents to Peak District National Park Authority it was determined on 17<sup>th</sup> January 2025 that the Neighbourhood Plan should move to Regulation 16 consultation and examination.

#### **3. Decision and Reasons**

3.1 The Peak District National Park Authority decided at the planning committee meeting (held 17<sup>th</sup> January 2025) that the Hartington Town Quarter Parish Neighbourhood Plan met or complied with Regulation 15 of the Neighbourhood Planning (General) Regulations 2012 and should proceed to Regulation 16 consultation and examination.

3.2 The reasons for this decision are that the Neighbourhood Plan complied with legal and procedural requirements.
