## Public Transport and Car Parks

---

### Public Transport

The COVID 19 emergency continues to affect local and national public transport. Until further notice most bus and rail services in the area will continue to operate to a reduced timetable.

Is your journey necessary? Government advice is for people to only travel by public transport if they can't use an alternative like walking or cycling.

Public transport passengers are required to wear face coverings from Monday 15<sup>th</sup> June. Parishes have expressed their desire for more reliable, regular and affordable services that can connect people to jobs, services and leisure. The Authority is working closely with Derbyshire County Council and other local transport bodies to gather data and coordinate actions and strategic planning for a low carbon and more integrated transport network for the Peak District. This includes demand responsive buses, enabling the expansion of our Hope Valley Explorer bus, rolling out Electric Vehicle Charge points, and expanding the opportunities for cycling. Feedback from Parishes can make a real difference and can be moved swiftly through our communications channels.

### Car Parks

Did you know? Our annual car park permit is just **£40**, and allows parking in any one of 18 Peak District National Park Authority Pay & Display car parks (plus of course, our 27 other free car parks). So if you use one of the car parks for a full day just twice a month, this could represent a saving of almost £75 a year (normal day rate £4.75). ## Visitor management and engagement

---

Our rangers continue to patrol regularly every day across the National Park with an emphasis on our car parks and the busiest visitor locations looked after by both ourselves and our partners. This week we have been able to bolster this capacity with the addition of four more members of the ranger team who are normally involved in our learning and discovery work, and around 30 volunteers focused on litter collection and patrols. 'Fire Watch' has also been operating for the last three weeks with volunteers making observations for fires in the open countryside, and speaking with members of the public having BBQs. Alongside our patrols, we continue to operate the Peak District 'car park alerts' system online, providing updates as we receive them to allow visitors to understand how busy some of the most popular car parks are and then move on to less crowded areas.

As a perfect counterbalance to the challenges of Covid-19, our teams have this summer witnessed a carpet of wildflowers appearing in fields on our Stanage North Lees estate – courtesy of hard work undertaken last year. So-called 'green hay' – collected from other areas such as our trail-side verges and packed with native seeds, made its way to our Stanage North Lees estate courtesy of our Cut-and-Collect machine. This technique allows us to not only maintain the conditions needed for wildflowers to thrive, but also feed new areas with species from right on our doorstep.

Our digital communications will continue to focus on many of the key issues raised by communities, including litter and inappropriate parking. We are also piloting 'geo-targeted' social media campaigns to new urban audiences, taking our #PeakDistrictProud content direct to them alongside those who already 'follow' us on our channels.

Finally, supporters of the Peak District National Park Foundation will be hitting the road for the summer solstice as trustee Alex Waddington takes on an epic dawn-til-dusk cycle ride this weekend on a sponsored litter pick. Many volunteers have already offered to meet Alex on his 'Spin and Bin' route to collect bags of litter as he makes his way through the 16-hour challenge.
